You must print this form on school stationery if it is completed by a school official at your student's current school.

Students who don't have a photo ID may submit this form in place of an approved form of student ID. Once completed, this **Student Identification Form** serves as an acceptable photo ID for ISEE test-taking purposes. - ✓ This form is valid only if signed or sealed by a school official at the student's current school or a notary.

School Official or Notary Be sure to place your seal or write your signature in ink so that it partially overlaps the student photo.

Student Photo Requirements:

- ✓ A school official at the student's current school or notary must place their seal or write their signature in ink in the box at the left so that it partially overlaps the student's photo.
- ✓ The photo must show the student only (not a group photo).
- ✓ Photo must be taken within six months of the testing date.
- ✓ Photo must be clear without shadows or dark spots obscuring the student.
- ✓ The photo must show a head and shoulders view with the student's entire face, both eyes, and hair clearly visible. A head covering worn as religious observance is acceptable.
- ✓ Photo may not be altered in any way using media filters, lenses, or icons.
